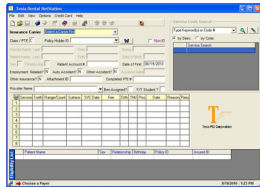

WorkStation™ / NetStation™

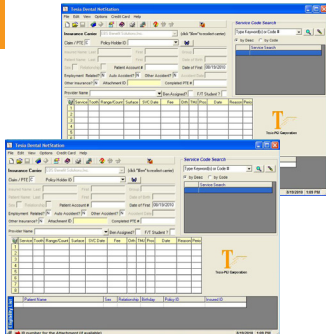
